1. FIREFIGHTERS' PENSIONS TOP UP GRANT 2010

- 1.1 In March 2010, Fire and Rescue Authorities were requested to submit their audited 2008/09 pension deficits/surpluses and their unaudited 2009/10 pension deficits/surpluses to CLG by using the Department's online data collection/grant payments system, LOGASnet. All requested data has now been received and each FRA's top up grant for 2010 has been calculated and processed for payment. FRAs should receive their grants on **15**th **July 2010**.
- 1.2 Payments of the Top Up grant 2010 will cover 80% of the estimated pensions deficit for 2010/11 that FRAs submitted in October 2009; the remainder of the 2009/10 requirement; any audit adjustments as required in regard to 2008/09. I annex a table which sets out the value of the pension Top Up grant for each FRA.
- 1.3 A '*clawback exercise*' was carried out in March to recover duplicate payments following the first special commutation payment made in December 2008. A number of these recoveries remain outstanding and these have now been offset against each FRA's Top-Up grant, where applicable (please refer to column F of the table).
- 1.4 FRAs will receive their Top-Up grants as one net payment. The different components of each FRA's grant have been identified on the annexed table where:

Column **A** represents the audit adjustment for 2008/09 (where relevant); Columns **B** and **C** represent the sums related to 2009/10. The data in column B represents 20% of the estimated 09/10 deficits which were submitted in October 2008. The data in column C represents the relevant adjustments following the submission of the 09/10 deficits in their unaudited format; Columns **D** and **E** represent the sums related to 2010/11. The 2010/11 component for Essex, Gloucestershire & West Yorkshire has been split into two parts as they were required to revise their initial LOGASnet submission; Column **F** represents any adjustment for outstanding debt relating to the December 2008 special commutation payment; and Column **G** represents the Net Top-Up Grant 2010.
